

**MINUTES OF THE ANNUAL MEETING OF THE  
CATHOLIC LAWYERS GUILD OF CHICAGO**

**WEDNESDAY, MAY 10, 2017**

1. **Introduction.** The Annual Meeting of the Catholic Lawyers Guild of Chicago (the "Guild") was held on Wednesday, May 10, 2017, in the Jenner & Block Conference Center at 353 North Clark Street, Chicago, Illinois, commencing at 5:30 p.m. A quorum of members was present in person.  Treasurer: T. Nicholas Tyszka


On motion of Mr. Simon, duly seconded, the Motion to elect the officers proposed by the Nominating Committee was unanimously approved.

11. **Closing Prayer.** Fr. Bob Cook delivered the closing prayer.
